

As the senior public health official for BC, the Provincial Health Officer (PHO) is responsible for monitoring the health of the population of BC and providing independent advice to ministers and public officials on public health issues. Two primary pieces of legislation that govern the work of the OPHO are the Public Health Act and the Drinking Water Protection Act.


About the 360° COVID-19 Review Project with the BC OPHO

The 360° COVID-19 Review Project is part of the Unlearning and Undoing White Supremacy Project, aimed at identifying and arresting inherited white supremacy and anti-Indigenous racism in our day-to-day work and lives. The Unlearning and Undoing White Supremacy Project works to embed Indigenous rights, truth, and reconciliation across the health system.

The 360° COVID-19 Review will focus on daylighting systematic white supremacy and Indigenous specific racism in the BC OPHO and its influence during the COVID-19 pandemic response. So far, there has been no systematic look at the ways in which Indigenous specific racism, white supremacy, and settler colonialism showed up within the COVID-19 public health response. These findings will be shared with public health leadership for the development and implementation of anti-racist pandemic response strategies for future public health threats. This review aims to begin action on *Recommendation 15* of the In Plain Sight report¹.

Project Goals

Over the next one year, we will seek to: (1) illuminate which BC OPHO structure, policies, practices, norms, and values upheld systemic white supremacy and racism during the COVID-19 state of emergency; (2) catalogue the colonial knots that arose within the BC OPHO's sphere of influence during

the COVID-19 state of emergency; and (3) share findings with public health leadership towards development and implementation of anti-racist pandemic response strategies for future public health threats.

Tasks For You to Offer Your Mind, Heart, and Hands

We are guided by the wisdom of Dr. Camara Jones, former president of the American Public Health Association, who launched a national campaign against racism. Her 'Science & Practice of Anti-Racism' framework² outlines three tasks: (1) naming racism; (2) asking, how is it operating here?; and (3) organizing and strategizing to act. Puglaas Hon. Jody Wilson-Raybould (Kwakwaka'wakw from We Wai Kai Nation) offers further guidance in her framework of Learn, Understand, and Act³. There are many opportunities for Indigenous student(s) to contribute to elements of this work.

Naming Racism	 Engage with the OPHO's weekly Unlearning & Undoing meeting, in a way that feels comfortable to you. Grow your own learnings on this topic in any way that you feel you need.
Asking, How is Racism Operating Here?	 Contribute to an in-depth review of BC OPHO orders and COVID-19 briefings through the lens of anti-racism and Indigenous rights. Participate in identifying the BC OPHO structures, policies, practices, norms, and values that upheld systemic white supremacy and racism during the COVID-19 pandemic. Learn from Indigenous voices that have already spoken truths regarding individual and community experiences during the pandemic.
Organizing & Strategizing to Act	 Participate in cataloging and describing 'colonial knots' that arose within the OPHO's sphere of influence during the state of emergency. Identify ways in which Indigenous rights, and Ways of Knowing, Doing, and Being were, or investigate how they could have been, upheld during the pandemic response. Consider ways in which 'trustworthy' public health might look for Indigenous Peoples. Collaborate with the BC OPHO team and partners to consider how evidence generated will support decision making in relation to future public health threats.
